Welcome to the Virginia Beginning Farmer & Rancher Coalition Project: A Spring Update

Since 2010, the VA BFRC Project has taken on a threetier approach where project activity occurs at local, regional, and state levels to meet the needs of Virginia's aspiring and establishing farmers. With the Coalition at the heart of the project, innovative farm businesses and organizations are coming together across the Commonwealth to support beginning farmers through classroom, online, and hands-on learning opportunities. The project uniquely includes a mentoring component through which beginning farmers can gain access to the knowledge of Virginia's experienced farmers.

Whole Farm Planning Programs Available for Farmers

Whole farm planning is distinct from other farm planning approaches because it ties all the planning you do together for the whole farm. This holistic approach is based on the longterm vision you and your family has for itself and the farm—now and in the future to maintain and improve profitability while enhancing sustainability.

The new curriculum for Virginia beginning farmers and ranchers is focused on whole farm planning; it comprises five modules: 1) Introduction to Whole-Farm Planning, 2) Land Acquisition and Tenure, 3) Marketing, 4) Sustainable Farming Practices, and 5) Holistic Business Management. Keep an eye out for soon to be expanded farmer profiles and case studies. The implementation of 7 Virginia Beginning Farmer and Rancher Coalition teams will be executing Whole Farm Planning programs for beginning farmers/ranchers starting Spring & Summer of 2012.

What are the needs? A Look at the 2011 Beginning Farmer Survey

According to the USDA, beginning farmers and ranchers nation-wide face unique challenges to develop and sustain new farming operations. Gaining access to land, capital, markets, and educational opportunities are the leading barriers for successful farm start-up.

In spring 2011, the Coalition designed and implemented an online survey to identify Virginia beginning farmer and rancher demographic characteristics, program area needs, and program delivery preferences. The survey was developed by drawing upon community-based participatory research principles where the Coalition directly participated in the survey design and implementation. Survey results guided the development of the Virginia Whole Farm Planning Curriculum, which is currently being implemented across Virginia.



Over 200 farmer and servicer provider participants completed the instrument. Respondents prioritized one-day workshops, farmer-mentoring, & online learning opportunities as primary delivery methods. Respondents also indicated priority programming areas, for example: financial risk management for small farms; gaining access to affordable financing; insurance issues and regulations. Regional focus groups and case studies are being conducted to continue to learn more about educational needs and delivery preferences . For full survey report, visit www.vabeginningfamer.org.

Virginia's Farm Mentor Network

A Farm Mentor Network facilitates the exchange of knowledge & skills of experienced farmers & rancher with the next generation of agriculture. As a statewide effort, we have been working to establish the Farm Mentor Network.

Kelli Scott (Floyd County) has been working as Farm Mentor Coordinator in southwest Virginia since last June. In January, 2012 we welcomed CJ Isbell as Farm Mentor Coordinator, Central Virginia. CJ is a beginning farmer living in Hanover County. We are also working with Jim Hilleary from the Fauquier Education Farm in Warrenton, VA. Jim is working as the curriculum coordinator implementing Virginia's



Whole Farm Planning program. He also assists in connecting beginning farmer students (participants) enrolled in the program at the education farm with the mentor network.

Kelli, CJ, and Jim work as a team to facilitate and channel the skill, knowledge, and experience of the established farmer to share it with the beginning farmer community. How can this be accomplished?
